The Mix

Final Permits were granted in January. LaRaine's lost right of way on their driveway because is was a few inches onto the Mix land. Right now we need to have a better understanding of how the permitting works. The Mix has been granted several extensions on their building permits, and how does that fit in with the new NC zoning.

Joe will obtain the liquor licenses to gain an understanding of how they are tied to parking spaces, and which of those spaces are tied to the spaces they are building

Status of Street-scape construction

Some Rupley residents were concerned about new lane markings. A meeting was called and members of the board, residents, and property owners walked the area to review. It has been suggested that changes be made to plan as drawn now – the pass is potentially too narrow. We need a light box on the main "landscaped" island.

Landscaping plan – trees will go in around October.
