Other Guests:

- Samuel L. (Lee) Reid, Executive Director of the Atlanta Citizen's Review Board (ACRB) presented on their new mediation program between citizens and police officers. ACRB was created in 2007 and opened doors in 2008. Main objective is improving relationship between APD and citizens. Mediation board created to handle less serious complaints (rudeness, minor policy violations, minor detentions). Program is voluntary. Most police officers have been agreeable to participating in the program. Mediation must be initiated by citizens. At this point in time, police officers cannot initiate mediation with citizens. There are 5 mediators, including 2 retired judges, all with at least 5 years of medication experience. If the incident does not settle during the mediation, there will be an investigation.
- Erin Colie, Event Director of Atlanta Sport and Social Club re planned Atlanta United Block Party to kick off their 2018 MLS season at Briarcliff Place and N Highland Ave.



Erin did not attend the meeting. NPU Chair provided the following report: large event application for 4 hour event on March 10th. Gated, 21 and over event for \$15. North Highland from Greenwood to Drewry, and Briarcliff Place adjacent to the parking lot will be closed. They have not presented a transportation plan and have not indicated how they will close off the street. Closed street will cut off main access to American Roadhouse parking lot. Large Gathering events do not allow purchase of alcohol at private business and bring to public areas. Application was mailed in on Thursday. Large Gathering permit will not be heard by the NPU.

- Request for letter from VHCA: crowd is variable, minimum parking spaces for Dark Horse should be maintained. Tickets are available the day of the event so tickets will not limit the crowds that come to the neighborhood for the event. Letter should indicate we welcome Atlanta United and other events which bring visitors to our business districts, but we need to have concerns addressed.
- Motion for Planning Committee to Submit a Letter to the City's Officer of Special Events and Major Klotzer Expressing Concerns Without Seeing Plan for the Event Carries on Show of Hands: 7 yes, 1 no.
